# WELCOME AND OVERVIEW

Social work educators often assign students to become involved in community change activities, and the question inevitably arises: How do you find out about such things? Are there specific groups who advocate for changes that align with social work values and if so, who are they? Despite the advances of the internet and online search engines to help us find the resources we need in our practice lives, it is often difficult to find a centralized list of advocacy organizations that is current, comprehensive, and which contains information about national, state, local and regional activities. This reference manual is a modest attempt to fill that void. We are grateful to the KU School of Social Welfare's Center for Community Engagement and Collaboration (CCEC) for allowing us to publish this resource as part of the Center's work.

To create this document, we have looked for resources in a wide range of social activism, advocacy, community development and community organizing to determine some of the key organizations, coalitions and others advocating at the national level, and at the state and local level in Kansas and Missouri. We also have located local advocacy organizations in the Greater Kansas City/Overland Park metropolitan area and some in Topeka and Lawrence, KS. For each, we list the name of the organization, their mission statement, and their website.

The document is arranged alphabetically by topic areas of interest to social workers, people in human service work, and those interested in good government and improved social infrastructure generally. Some of the organizations are listed more than once, as many are multi-issue groups working to have impact on several interrelated areas of policy. While we identified numerous topics, we recognize that the topical list is not exhaustive, nor have we identified all the groups and organizations involved in each area we have identified. Further, as identification of advocacy organizations begins—as does all social work and any social change effort—from one's own positioning, there are likely omissions that reflect our own social networks, perspectives, and identities. Thus, we also are open to suggestions for additions to the handbook both in terms of advocacy areas and specific agencies involved in the areas we have identified. This list is not an endorsement of the quality of the work being conducted by any of these agencies nor the alignment of all their campaigns and tactics with social work ethics; while we are familiar with some, the breadth of the organizations is simply too wide for us to be familiar with, or to have vetted all of them. If anyone has suggestions that an organization might be problematic in some way, we will welcome that feedback so we could do further research into whether it should be included in the list.

We hope that you find this Handbook helpful, and that it motivates your involvement in advocacy, coalition building and social change. We wanted to create a social justice resource handbook which reflects and amplifies the KU School of Social Welfare's Mission, Values, and Goals and wished to help to operationalize the school's goals of ... "transforming lives and social contexts and promoting social,

economic, and environmental justice in Kansas, the nation and the world." There is much work to be done to ensure a society that is more equitable, more inclusive, and that gives everyone a voice in policy, laws, and community decision making. Our society is much improved when all of us have a voice and a seat at the table, and we hope this will help you to find ways to amplify your voice and the voices of populations about whom you care.
